- Teams will play a minimum of 3 games

We ask that each participant send a \$60 check for summer league and another \$60 check for the tournament made payable to FARMINGTON BOYS BOOSTER CLUB . In the event that your family meets the volunteer requirement at our MYAS fundraiser tournament on April 13-14th, the summer league will be free and the \$60 summer league check will be torn up. (8th graders not eligible for summer league can register for only the Breakdown tournament and only need to send one \$30 check.)

Please note that roster space for summer league is limited. Therefore current 9-11th graders who were on the winter school basketball teams will be given priority. After that priority will be given to who turns in their registrations first.
